Snohomish County Marine Resources Advisory Committee Meeting Summary, Wednesday, January 20, 2010, 6:30 – 8:30 PM

Welcome, Introductions, and Announcements

Jerry Masters opened the meeting at 6:35 PM.

Introductions were made for those attending the meeting.

Nearshore Sediment Study Grant: Arden Thomas

Arden Thomas announced \$142,280 funding was received from the Salmon Recovery Funding Board (SRFB) to work on the Nearshore Sediment study. This grant leveraged \$25,000 of NWSC funds. NWSC funds will be in use beginning July 1, 2010. The first phase of the project will include biological and physical analyses to identify and rank locations for nearshore habitat restoration locations. Stakeholder meetings will be held to discuss the results of the analyses and potential design approaches.

Shoreline Master Plan Update: Kathleen Herrmann

The Snohomish County Planning Commission will hold two meetings regarding the Shoreline Master Plan update. The first will be a briefing with no public testimony on January 26, 2010, and the second will be a hearing with public testimony on February 23, 2010.

A decision was made for the MRC to review the updates as a group, with Jerry Masters taking the lead on reading the document, with input from Mary Cunningham. The MRC will reach out to Heather McCartney for comments.

It was noted that the first 10-15 pages of the amended draft is likely most applicable to MRC interests, especially for areas like Port Susan and the potential Marine Sanctuary Area (MSA).

Puget Sound Starts Here! Campaign: Kathleen Herrmann

Stickers were passed out depicting the Puget Sound Starts Here! logo.

Northwest Straits Initiative Funding: Kathleen Herrmann

Washington State Senator Patty Murray announced that \$1.6 million was secured in the 2010 spending bill for the Northwest Straits Marine Conservation Initiative.

New Edmonds Port Terminal, Friends of the Edmonds Marsh, and Sound Stewards

Keeley O'Connell announced that the Friends of the Edmonds Marsh will hold a meeting on April 8, 2010. People for Puget Sound are holding a Sound Steward training in late February.

Friends of the Mukilteo Waterfront

Jerry Masters announced that a new group with similar interests of the MRC has formed, Friends of the Mukilteo Waterfront. They are working to restore waterfront access in Mukilteo.

Puget Sound Processes: Lincoln Loehr

Lincoln Loehr gave a presentation about currents and processes in Puget Sound.

MRC Administration Updates

MRC recruiting process opened for additional positions: Kathleen Herrmann

Currently, the MRC has 10 members and 1 ex officio member. The Stillaguamish Tribe position is open, and the Committee is authorized to have one additional member. Discussion surrounded the creation of a position with a new designation, possibly a Beach Watcher, a representative from the Stillaguamish Clean Water District, or an At-Large member.

High interest was expressed in finding an individual who could commit a significant amount of time to the MRC, especially in areas of administration and project management. An email will be sent out to MRC interested parties to advertise for new MRC members.

NWSC Grant Contract: Kathleen Herrmann

The \$305,000 NWSC Grant contract was signed by the NWSC and approved by the Snohomish County Prosecuting Attorney. It will be submitted through the County ECAF process to the Council this week. The MRC Annual Report and invoice will be submitted with the signed grant contract.

NWSC Progress Report: Kathleen Herrmann

A draft of the MRC progress report for the first quarter of the 2009-2011 NWSC grant period was submitted on January 15, 2010. A copy was provided at the meeting.

MRC Bylaws: Kathleen Herrmann

Amendments to the MRC bylaws will need to be completed over the next few months, with the help of MRC members.

MRC Snack Sign-up: Kathleen Herrmann

A sign-up sheet was distributed for refreshments for future meetings for each MRC member to sign.

Mussel Watch: Andrea Hennings

Sampling will take place on Monday, January 25 and Tuesday, January 26, 2010 with Mary Cunningham, Lincoln Loehr, Mike McHugh, and Alan Mearns site leads.

MRC members, Jerry Masters, Tom and Maureen Hoban, and Dena Peel have signed up to sample, along with volunteers from Beach Watchers and ORCA students from Everett Community College.

The partnership between the Snohomish County MRC, WDFW, WA Sea Grant, Puget Sound Partnership, and Amy Johnson continues to provide a model for citizen science monitoring in Washington State. The first training took place in Port Townsend on January 8, 2010, with training for the Whatcom MRC and Seattle Aquarium Beach Naturalists taking place on January 22 and 23, 2010, respectively.

NWSC Update: Tom Hoban

Tom noted the next NWSC meeting will be taking place at Edmonds City Hall on January 29, 2010.

The NWSC continues to work on the derelict Gear project, with approximately 35% of the derelict nets removed from the Northwest Straits. As the readily accessed nets will be removed first, future years work on the project will likely be slower or less productive due to the inherent difficulty of retrieval. Currently, there are four boats and crews working full time on the project.

Other topics of interest included a section in the NWSC newsletter about Jerry Masters, the NWSC's continuing efforts to involve the Outer Coast MRC's, and the continued interest in rockfish conservation in the San Juan Islands.

Port Susan MSA Update: Kathleen Herrmann

The workshop will take place on January 27, 2010 at the Warm Beach Christian Camps and Conference Center in Stanwood, WA. The workshop will bring together 29 scientists from a broad array of specialties to identify biodiversity targets for this unique area.

The services of a professional facilitator have been secured to guide discussions. MRC members and staff in attendance will include Kathleen as a small group facilitator, Lincoln Loehr and Mike McHugh as scientists, Mary Cunningham and Chrys Bertolotto as note-takers, and Tom Hoban as an observer.

Kayak Point Update: Kathleen Herrmann

Project Design

Snohomish County staff are reviewing Coastal Geologic Services' 100% restoration design for the storm berm area along the southern portion of the point. The design includes removal of a portion of the bulkhead, relocating the road landward, installing a storm berm to mimic natural processes and facilitate sediment transport processes, and guidelines for restoring the backshore area with native plants.

The Kayak Point Team is working to develop a vision statement to guide the development of two designs, which will be integrated with CGS restoration design. A second public workshop will be held in April 2010 to present design options to the public. A single, final design will be completed in early May based on the results from this workshop.

Pre-restoration Monitoring

Pre-restoration monitoring was completed in August 2009 on 5 parameters including elevation, substrate analysis, nearshore algal and vegetation coverage and biotic communities. Data was collected and cataloged by WSU Beach Watchers.

Problems Encountered

The deliverables the consultant submitted on December 31, 2009 to the MRC are currently under review; however, the initial assessment is that the design drawings and specifications are not sufficient to develop a bid package. Snohomish County plans to submit a comment disposition and resolution form to the consultant. Depending upon the consultant's response, more funding may need to be allocated to project design to develop the documents and plans necessary to create a 100% design and bid plans and specifications.

WSU Beach Watcher and Shore Stewards Update: Chrys Bertolotto

The Beach Watcher program will hold their 2010 training for new recruits. A new outreach plan is focusing on newly retired individuals to increase participants. The message, "Crafting Your Volunteer Experience" is being used on fliers, newspapers, and paid radio advertisements. During last year, 60 volunteers reported over 4000 hours of service with Beach Watchers.

Of the current goal of 100 new Shore Stewards, 86 have been recruited. Shoreline community workshops are being held in conjunction with the Shore Stewards program, with one in the Stillaguamish watershed focused on water quality and LID on February 4, 2010 and another in the Tulalip area focused on coastal processes, erosion, landscaping, and a septic system update by Brent Hackney on February 20, 2010. The goal for these workshops is to have 100 participants. Current partners for the workshops include Tulalip tribes, Stillaguamish tribe, Snohomish County, and the Snohomish County Clean Water District.

Crabber Education Update: Brent Hackney

A number of advancements were made on this project, including Beach Watchers Judy Ness and Joy Lynch obtaining space on local radio for public service announcements and sending out solicitations for information from crab pot manufacturers.

Recent subcommittee meetings focused on how crab pots are lost, an educational poster for display at local sporting good stores and marinas, and new outreach materials and action statements. A draft poster was distributed to the subcommittee for comments, and a map with hazards and best management practice reminders is in development for distribution during crabbing season. A YouTube video is also in the works for a visual on how to set up a crab pot.

Chrys Bertolotto and Andrea Hennings worked to finalize a timeline for the project, as Andrea will now spend 1/3 of her contract time with the MRC on this project.

Meeting Feedback and Project Updates: Jerry Masters & Kathleen Herrmann

Jerry and Kathleen noted the need to begin brainstorming for new MRC projects. In the future, time will be allotted within the agenda explicitly for this purpose. Morgan Schneidler's presence was requested for those meetings, as her insight into the Puget Sound Partnerships priorities could be used as a guide.

Jerry Masters adjourned the meeting at 8:30.

Welcome, Introductions, and Announcements

Jerry Masters opened the meeting at 6:30 PM.

Introductions

A special introduction was made for Tim Walls, Senior Planner for Snohomish County and Chair of the Snohomish Basin Salmon Recovery Forum.

Puget Sound Partnership and Local Integrating Organization's: Tim Walls and Kathleen Herrmann

The Puget Sound Partnership (PSP) is hoping to create Local Integrating Organizations (LIO's) to implement the Action Agenda. The Whidbey Basin Core Team has not yet resolved whether they could fully represent their organizations <u>AND</u> the PSP in the implementation of the Action Agenda. The Core Team is reaching out to the MRC's for their input and participation in proposing an LIO to the PSP. Three main questions are before the MRC:

- 1. Should the MRC have a representative to the PSP and should the MRC participate in an LIO?
- 2. Should the Whidbey Basin Action Area should be kept as the existing geographic area or broken into two groups?
- 3. What should the structure of LIO's and recommendations to PSP look like?

The current hierarchy and function of the PSP and its councils, boards, and panels were discussed, and a handout was provided detailing its legislatively dictated structure.

Chrys Bertolotto volunteered to help the Whidbey Basin Core Team develop a proposed LIO. Lincoln Loehr nominated and Mary Cunningham seconded. Jerry Masters volunteered to provide input and serve as an alternate on meetings Chrys might not be able to attend. Mary Cunningham nominated and Tom Hoban seconded. The nominations were approved. Lead Staff will support this process and attend meetings as necessary.

MRC Members

Jerry Masters noted the resignation of Dena Peel from the MRC due to personal issues. Her position will need to be filled, as well as the two other open positions on the MRC. Potential options for open positions include a representative from the Port of Everett a WSU Snohomish County Beach Watcher member (preferably retired or able to spend time on projects) and a member to serve as the MRC representative to a potential Local Integrating Organization. The possibility of alternate MRC members for each position was also suggested.

Port Susan Resolution

The Port Susan Resolution request was sent to County Prosecuting Attorney for review. A draft ECAF is ready to be submitted when the review is complete. After the ECAF is approved, it will take 6-8 weeks to go through Brian Perry and Public Works as resolution to the County Council for final approval.

MRC 2010 Workplan

The MRC 2010 Workplan draft will be distributed via email for comment.

Mussel Watch Update: Andrea Hennings

MRC staff facilitated volunteer citizen sampling efforts at eight sites in Snohomish County to collect mussels for NOAA's National Mussel Watch Program. The 18 participants in the program included MRC staff, four MRC members functioning as site leads, and volunteers from WSU Beach Watchers, Tulalip Tribes, NOAA, and the ORCA Program at Everett Community College.

Two of the regular sample sites did not have enough live mussels to sample; including Kayak Point Regional Park and Edmonds Marina. All other samples were received by the labs in great condition and are being processed for analysis. The shift in the NOAA Mussel Watch program to a citizen science program has facilitated the prioritization of Washington State samples. NOAA has all available samples online for public access in their data portal. Mike McHugh volunteered to collect mussels for the Kayak Point site, should they still be available.

MRC Budget Review: Kathleen Herrmann

Of the \$80,000 the Snohomish MRC requested from the County, the County Executive approved \$53,145 for 2010; the lower amount is due to County revenue shortfalls. An expenditures sheet was provided detailing the current MRC budget. Changes could be made within certain categorizations or broken down further to show more detail.

The MRC members requested a two year budget for review at the next meeting based on the April 2009 meeting minutes. As Jerry Masters and Jared Bond were part of the original budget drafting process, their help was solicited for explanation of the distribution of funds. Keeley O'Connell will also help with this effort.

The status of the Marjorie Mosher Schmidt Foundation funds was discussed. Staff will provide a summary of this funding at the next MRC meeting.

NWSC Update: Tom Hoban

The January NWSC Meeting was held in Edmonds. Snohomish County Executive Aaron Reardon attended and Public Works Director Steve Thomsen gave the opening remarks. Kathleen Herrmann gave a presentation on Mussel Watch, which garnered positive reviews from those in attendance.

A NWSC retreat will be held on Whidbey Island from February 25-26, 2010 of which Tom Hoban and Kathleen Herrmann plan to attend. Additional announcements were made on a White House report on ocean acidification, the Port Susan Marine Sanctuary Area workshop, bills currently in the Washington state and National congresses, Coastal MRC's, and NWSC funding.

Jerry Masters responded to the NWSC request on how MRC's could better utilize NWSC staff. Suggestions included integration of Caroline Gibson into Snohomish County MRC projects.

COMPASS Workshop: Kathleen Herrmann

The Northwest Straits Commission hired Liz Neeley of COMPASS to conduct a workshop tailored to the needs of the MRC's. NWSC is planning three workshops: one in San Juan County, one in Mt. Vernon for the Snohomish/Skagit/Whatcom MRC's, and one for the Jefferson/Clallam/Island MRC's. They will focus on communicating the work of the MRC, particularly to decision makers such as County Councils and Executives, and journalists, but will also be useful for helping to develop messages for any audience. Suggestions for Snohomish County messages include those related to the Port Susan MSA and Dungeness crab protection. Sasha Horst will need to do registration in advance, and participants will be asked to send a short biography ahead of time and make a first cut at a "message box" template, which she will provide.

The date suggested by the Snohomish MRC for their workshop is Thursday, May 13, 2010. Suggestions on topics will be submitted by email.

Kayak Point Update: Keeley O' Connell

The second Kayak Point Regional Park visioning workshop will be held on March 31, 2010 at 6:30 PM at the Lake Goodwin Community Club in Stanwood. Snohomish County Parks & Recreation is proposing new design plans for the park's day-use area and wants public input.

Outreach efforts for this workshop will be similar to first workshop, although no canvassing will take place. Other interest groups are being approached for input at the next meeting, including the tribes, YMCA, Boys and Girls Club, and boat launch users. This effort is being coordinated by Allison Sanders from Surface Water Management.

Coastal Geologic Services, Inc. (CGS) has been given final comments on their 100% restoration design. Another final draft will be available from CGS in a few weeks. This restoration plan will not be flexible at the workshop, but multiple recreational design options will be available for viewing and voting. The finished design containing the final restoration and recreational plans will go through the permitting process.

The workshop announcement text will be send to the MRC members for distribution.

Gravid Female Crab Habitat Project: Kathleen Herrmann

This topic was held for future discussion. Handouts of maps created by Surface Water Management GIS staff were distributed, which included the current data from the gravid female crab habitat study being conducted by WDFW and Tulalip Tribes.

Shoreline Master Plan Update: Jerry Masters and Mary Cunningham

7:05 Shoreline Management Program Update & MRC Recommendations- Mary Cunningham

Mary Cunningham identified four main areas within the Shoreline Management Program (SMP) update which could affect marine areas and be of interest to the MRC:

- 1. Structural bank stabilization to protect designated farmland.
 - Should the MRC recommend structural shoreline stabilization not be allowed to protect designated farmlands along marine shorelines?

Within the SMP, dikes are likely considered armoring and would constitute bank stabilization. Therefore, replacement of dikes and rearmoring for sea level rise would be covered by this update. If the SMP is held to "no net loss", bank stabilization would need to be landward of any associated wetland. It would also allow marginal farmland to be diked, even if it's not currently farmed.

- 2. Public access would be reduced and only required for public and utility developments, nonwaterdependent commercial, industrial and recreational uses, and for residential uses of more than four units. Water-dependent uses would not be required to provide public access.
 - Should the MRC recommend public access also be required for water-dependent commercial, industrial and recreational development along marine shorelines?

There are only nine designated public access points in the County, including shoreline viewpoints and marinas. Examples of marine access in areas designated as water-dependent include Port of Everett trails around marinas and through the industrial area of Everett to Pigeon Creek No. 1.

- 3. The SMP allows nonwater-dependent commercial, industrial, and recreational uses in shoreline jurisdiction if "navigability is severely limited at the proposed site and the use provides public access or restoration of wetlands or fish and wildlife habitat".
 - Should the MRC recommend <u>both</u> public access and restoration be provided along marine shorelines when nonwater-dependent uses are allowed?

The City of Everett has code within their SMP which requires both public access and restoration along marine shorelines for nonwater-oriented uses.

4. 3.2.4. Public Access Element (*Policies*):

"14. When restrictions on access are deemed necessary for the health, safety or welfare of the public or for the protection and maintenance of the particular site, the type and extent of public

access should be defined through precedent established by Shorelines Hearing Board decisions and the courts. Restrictions on access may delineate times of access or allow access only to residents of a certain community or development."

• Should the MRC recommend the language "or allow access only to residents of a certain community or development" be deleted?

"17. Nonresidential water enjoyment and nonwater oriented uses and developments that front on the shoreline should provide continuous public access along the entire site's shoreline."

• Should the MRC recommend continuous public access be required for all nonresidential water enjoyment and nonwater-oriented commercial, industrial and residential uses on marine shorelines (In other words, should water-dependent and water-related uses not have to provide the continuous access, but other types of developments would)?

The City of Everett's code requires continuous access for water enjoyment and nonwateroriented uses. Current County regulations do not implement the policy as written, and include language which only requires a walkway directly to a waterfront use area or an area on the property which the water and water activities can be observed.

All suggestions for comment were agreeable to the MRC. Mary Cunningham will draft a letter on behalf of the MRC to submit to the Snohomish County Council. Comments on the letter are requested prior to the next MRC meeting on April 21, 2010 so the draft letter can be approved at this meeting.

The question of set back and buffer requirements was also raised. Mary will identify size requirements and distribute the information to the MRC.

Handouts outlining potential MRC comments to the Snohomish County SMP update and maps of Snohomish County shoreline were provided.

Derelict Gear Removal Project

A June 2010 deadline has been set for the current removal project due to the NWSC 2009-2010 grant cycle ending.

The results of a study commissioned by the NWSC examining the biological and economic cost of derelict crab pots and their removal were released recently. The report noted that approximately 178,800 kg of legally harvestable crab within Washington State waters of the Salish Sea die in derelict crab pots each year.

It is fed by Willow and Shellabauger Creeks, with outfall pipes draining offshore which limit saltwater intrusion. The marsh is noted as habitat for Coho salmon and the site of a recently reoccupied great blue heron rookery.

A restoration project in Edmonds Marsh could include reestablishment of a barrier estuary through the construction of a railroad bridge and removal of sediment fill. Project partners and stakeholders include Sound Transit, the City of Edmonds, Friends of the Edmonds Marsh and others.

A draft of the 2009 Annual Report was emailed to MRC members for comments, which were due by Wednesday, February 24, 2010.

Recommendations to the County Council and Executive for inclusion in the 2009 Annual Report were approved through a motion by Lincoln Loehr and second by Mary Cunningham.

8:30 Budget Review- Kathleen Herrmann

A handout was provided detailing the working 2010 MRC budget from Snohomish County WMA fees, which listed the projected and approved amounts and staff recommendations for disbursement.

The Snohomish MRC requested \$80,000 for projects for 2010, of which \$53,145 was approved in October 2009. The reduction was decided at the Executive level due to Snohomish County revenue shortfalls.

Approximately \$27,000 was cut from various projects including the Port Susan MSA, a Water Quality Study, and the Shore Stewards/Workshops. \$5,000 will be provided to the Shore Stewards Workshops along with the \$16,500 provided by the NWSC grant.

MRC staff was authorized to move forward with the recommended budget for WMA fees for 2010 and make necessary future changes to the budget provided it doesn't add up to more than 10% of the overall budget, as motioned by Lincoln Loehr and second by Keeley O'Connell. The "Notes" listed on the handout were for reference and not approved as part of the budget.

6:50 Recreational Crabber Update- Chrys Bertolotto

Chrys Bertolotto presented the current drafts of the outreach poster and the educational map, both of which will be distributed and displayed during the 2010 crabbing season at area marinas, boat launches, and piers. Handouts of the poster were provided for comments. The map was projected for comments during the meeting.

- Main action statement: "Keep your crab pot, eat more crab"
- Comments on the map from meeting attendees:
 - Use the words "sinking line" rather than "weighted rope"
 - Is there a way to overlay areas where crab pot loss is greatest?
 - Dates of sailing regattas can be found online

Andrea Hennings conducted a survey of recreational crabbers at the April 13th Coastal Conservation Association (CCA) meeting. 24 surveys were received out of 75 attendees. While this survey is not statistically significant, results show that 70% of those surveyed who had lost crab pots believe they were stolen or vandalized. This information will help the MRC move forward with crafting messages to reduce the number of lost crab pots.

Brent Hackney and Chrys Bertolotto will give a presentation at the next CCA meeting on May 11th on the MRC work to educate crabbers and will also present the results of the survey. Jeff June will be giving a presentation on the NWSC Derelict Gear Removal Project at the Northwest Straits Commission meeting on May 21st at the Maritime Museum in Port Townsend and June 8th at the CCA meeting at Bayside Marine in Everett.

Action Item: The Crabber Subcommittee will send Joan Drinkwin and Caroline Gibson copies of the draft materials for comment before they are printed.

7:10 Benchmark Fund Discussion

The Northwest Straits Commission has approximately \$130,000 available for projects within the Benchmark Account. These funds are available to MRC's through a competitive project proposal process. One to three priority projects with measurable impacts within one year will be given funding. The money must be granted by June 10, 2010 and spent by December 30, 2011.

Projects with budgets greater than \$50,000, are regional in scope, and have the ability to leverage additional resources are encouraged. Further guidelines and rules for projects were distributed to the MRC through email and handouts.

Preliminary proposals will be made at the NWSC meeting on April 23, with the submission deadline on April 30, 2010. Once projects have been identified for funding, the money will be available for use beginning June 30, 2010. Individuals who suggested a project are noted in parentheses.

Project ideas:

- Mussel Watch: From Data to Action (Kathleen Herrmann)
 - Conduct a pilot project for two or more Mussel Watch sites in the Northwest Straits using volunteers to identify sources of data spikes. These would include researching current and historic inputs.
 - Recommendations to affect change would be developed, with the potential to include monitoring or cleanup efforts with stakeholders and government agencies.
- Port Susan MSA (Kathleen Herrmann)
 - Work with Island County MRC and Washington Sea Grant Citizen Science Program to build on current funding for the Science Workshop to identify critical threats to Port Susan by using volunteers as citizen scientists.
 - Kit Rawson from the Tulalip Tribes is interested in a citizen science program to gather initial data for the project.
 - An existing monitoring plan using WSU Beach Watchers as citizen scientists was previously denied funding from another source.
- Recreational Crabber Education (Chrys Bertolotto)
 - Use the regional expansion of the Escape Cord program as a model for extension of the current Snohomish County MRC Derelict Crab Pot Education Program.
 - Up to five other counties may be interested.
- Snohomish River Estuary Monitoring (Chrys Bertolotto)
 - Use citizen scientists for a monitoring project within the Snohomish River.
 - Work with the Snohomish County Citizen Monitoring group.
- Marine Invasive Species Monitoring (MISM) program (Chrys Bertolotto)
 - Partner with Nahkeeta NW and citizen scientists to conduct monitoring for invasive species, including *Spartina* sp., European green crab, and *Sargassum* sp.
- Puget Soundkeeper Alliance (Chrys Bertolotto)
 - Conduct boater education regarding best management practices.
 - Puget Soundkeeper Alliance has an established plan, but not enough man power or funding to put the project in place.
- Edmonds Marsh Restoration (Keeley O'Connell)
 - A plan has already been established and multiple partners have committed to the project, including the City of Edmonds and Sound Transit.
 - Funding would go toward a feasibility study, as it needs to be completed for the project to go through permitting.
- Kayak Point Regional Park Restoration (Keeley O'Connell)
 - Funds could match money from People For Puget Sound to take the project through permitting.

Kathleen will present 6-7 ideas at the NWSC meeting on April 23. A subcommittee of Chrys Bertolotto, Lincoln Loehr, Mary Cunningham, and Jon Houghton will identify the projects for presentation, and individuals who raised project ideas will provide short paragraphs describing their topic.

7:20 Kayak Point Presentation- Chris Mueller

A feasibility study on Kayak Point Park was completed to determine potential restoration options at the Park. Early design, pre-construction outreach, beach profile and sediment-type monitoring were conducted with funding from the 2007-2009 MRC grant. Goals of the project include a 100% conceptual park design, continuation and completion of pre-restoration beach profile monitoring, and public engagement through a collaborative visioning process. Funding for the project from the current MRC grant must be spent by June 31, 2010.

Current project partners include the Snohomish County MRC, Snohomish County Surface Water Management and Parks and Recreation, and People For Puget Sound.

Three conceptual designs were developed after researching technical considerations specific to the area, visiting similar project sites throughout Puget Sound, and obtaining input from a range of individuals during two public visioning workshops and outreach to the Stillaguamish tribe, Tulalip tribes, and other key stakeholders.

The conceptual designs include removal of the bulkhead and road from the south point, maintain open lawn areas, built elements through the center of the park, parking away from the water front, exceedance of current and future stormwater filtration requirements, beachfront enhancement for habitat and recreational use, educational updates and additions, a separate boat launch for kayaks, and new pedestrian paths.

Individual concepts varied in the amount and location of parking in the day use area, use of a shuttle service, stormwater bioswales, location and size of built structures and play areas, and inclusion of a pocket estuary. Almost all elements within each concept are interchangeable.

Parks and Recreation staff are currently working to resolve a number of issues including, concerns with parking issues, including how many people are in the park each day and how many pay for access. Also Parks staff are working to determine whether or not to include the pocket estuary in the preferred design alternative. The Snohomish MRC is in support of the restoration of a pocket estuary while working to meet the needs of public access, education and outreach, and stewardship of the marine environment.

Action Item: Submit individual comments or concerns regarding the three alternative concepts to Sharon Swan through (sharon.swan@co.snohomish.wa.us) by April 23, 2010. These comments and the input from the visioning workshops will be considered when designing the final preferred alternative.

7:55 Shoreline Management Plan Comments- Mary Cunningham

Port Susan MSA Benchmark Discussion- Kathleen Herrmann

A proposal was made to the MRC to submit a joint request for NWSC Benchmark Funds with the Island County MRC to conduct critical threat assessment for the Port Susan Marine Stewardship Area (MSA). The money would fund data collection and measuring of the potential threats to designated targets by citizen scientists. Additional coordination would be provided by the Washington Sea Grant Citizen Science Program and WSU BeachWatchers.

Port Susan has been identified by The Nature Conservancy as an area of high biodiversity and important for conservation. It is also an area of diverse stakeholders within multiple jurisdictions, including local tribes, landowners, farmers, and recreational user groups. Due to the inherent complex nature of the area, it has been identified as a good candidate for a comprehensive ecosystem-based management approach.

A work group has been formed to create the Port Susan Marine Stewardship Area (MSA), including the Snohomish and Island County MRC's, Tulalip and Stillaguamish Tribes, the Northwest Straits Commission, and The Nature Conservancy. The work group is following The Nature Conservancy's Conservation Action Planning (CAP) process as a guide to establish the MSA. A handout was provided detailing the CAP steps.

The project has been refined through work group meetings, interviews with key stakeholders in 2008, and a science workshop involving 46 scientists in January 2010. The next step of the CAP process is to develop strategies and measures, including assessment of target viability and identification of critical threats. Target viability is scheduled for completion in June 2010. Benchmark money would provide funds for identification of critical threats by citizen scientists by fall 2010. Strategies and measures would be fully completed by 2011.

Benchmark fund project ideas are due to Connie Price by June 10, 2010. Snohomish County MRC staff and members would work with Island County MRC and staff to write and submit the proposal for approximately \$130,000.

• Action Item: The Snohomish and Island County MRC's will submit a joint NWSC Benchmark Fund proposal to support data collection by citizen scientist for identification of critical threats to Port Susan MSA designated targets.

Meadowdale Park Project Presentation- Jared Bond

Meadowdale Park is located in a suburban residential area of unincorporated Snohomish County near the Cities of Lynnwood and Edmonds. The park has heavy day use year round and camping is allowed with a permit during summer months. Access points include a main parking area in the northeast corner and an ADA parking area in the southwest corner near the beach. Beach access is through a tunnel under the railroad which is shared with Lund's Gulch Creek.

Lund's Gulch Creek runs westward through the park and is noted as spawning grounds for chum, Coho, and steelhead. Although the creek does not support a run of Chinook, it is listed as potential habitat.

The gulch is geologically unstable. Frequent two-year storm events flood the beach tunnel and blockages can occur after sediment and debris are moved from the hillside. The trail leading from the main parking lot has been closed for months after washouts, causing sediment to back up behind the railroad. Closed pools of water subsequently form in these areas, trapping salmon behind the blockage. Due to permitting requirements, resulting sediments must be collected and removed from the park.

According to the Snohomish County Drainage Needs Report No. 11 (December 2002), a wider box culvert designed for fish passage and construction of an off-channel pond adjacent to Lund's Gulch Creek should be considered for the Park, which would cost approximately \$433,000. Although not within their jurisdiction, the 2010 City of Mukilteo Shoreline Master Program update suggested creation of a pocket estuary or trestle bridge for the railroad to specifically increase fish habitat. Neither of these options addressed pedestrian access to the beach.

Jared asked the MRC to consider commissioning a feasibility study for public access independent of the stream system. The MRC was supportive of any improvements to the park for public access and fish habitat enhancement and passage, but determined any project within the park would be better conducted within the scope of a larger railroad and sediment transport study in the future.

Kayak Point Pocket Estuary Discussion

Snohomish County Parks and Recreation has requested feedback on the three alternative design options for the park. Parks has received some negative feedback from members of the public regarding the inclusion of the pocket estuary within the final preferred alternative. Groups who have submitted

feedback supporting the pocket estuary include the Snohomish County MRC, the Northwest Straits Commission, members from other MRC's, WSU Extension Beach Watchers, and members of the public.

Few pocket estuaries remain in Puget Sound due to filling and armoring of shorelines. Restoration of the estuary at Kayak Point would serve as an important resource to many marine species and park users. The park's restoration consultant, Coastal Geologic Services, has completed work on other projects restoring or developing pocket estuaries and lagoons. These include Shoal Bay on Lopez Island, Oak Bay in Jefferson Bay, and Seahurst Park North in Burien.

Additional information is needed by the County and Parks staff to determine the viability of a pocket estuary's structure and function over time. The MRC discussed conducting a feasibility study to gain this information, which is estimated to cost approximately \$20,000. The estuary will be included as a placeholder on the alternative plans should further studies indicate it would remain viable. Funds for this feasibility study are currently available through the Marjorie Mosher Schmidt funds. NWSC has requested these funds be spent in the near future. Matching funds would be available through a People For Puget Sound grant, which expires on April 30, 2011. A request was made to consider all possible consultants to conduct the feasibility study for this project.

Other suggestions for using funds at the park included paying for NEPA and SEPA reviews for permitting work on the southern backshore and beach and an archaeological review. These options would require additional research before they are discussed further.

• Action- The MRC voted unanimously to allot \$12,000 of Nearshore Project designated Marjorie Mosher Schmidt funds to match a \$12,000 People For Puget Sound grant to fund a feasibility study for a pocket estuary at Kayak Point Regional Park.

MRC Workplan and Priorities- This topic was held until the next MRC meeting on June 16.

Approval of MRC Meeting Summary- Jerry Masters

Announcements:

- A 150 ft net washed up at Kayak Point Regional Park carrying two crab pots and about fifty buoys on June 16, 2010. The net also contained live and dead fish and crabs.
- Meetings:

 - Snohomish Estuary Tour: June 25, 2010 from 2:00 PM- 5:00 PM
 - Puget Sound's inclusion in the EPA's National Estuary Program is being reviewed to ensure program eligibility. A three-day site visit with senior staff from the EPA and a visiting director from another national program will conclude their trip with a boat tour on the Snohomish Estuary. Jerry Masters and Kathleen Herrmann will attend as representatives of the Snohomish County MRC.
 - Brent Hackney attended the June 12, 2010 North Snohomish County Coastal Conservation Association meeting, where Jeff June gave a presentation on derelict fishing gear removal. Some highlights noted from the presentation included:
 - Over 3,000 nets have been removed over the course of the Northwest Straits Initiative's Derelict Gear Removal program.
 - The bodies of animals caught in derelict nets will only remain about 14 days after death due to predation by other animals.
 - Over 160 seabirds were killed by a single net removed from Warm Beach.
 - Jared Bond and Sharon Swan from Snohomish County Parks and Recreation met with representatives from Burlington Northern-Santa Fe (BNSF) railroad and discussed Parks' beach access plan for Meadowdale Park. BNSF stated they didn't have an official stance and options are currently being discussed.
 - A meeting between Jared Bond, Kathleen Herrmann, Sharon Swan and Doug Dailer from Parks will be held regarding a public meeting to gauge public interest for the project and identify the scope of work.
 - The Executive Subcommittee and Kathleen Herrmann presented the 2009 MRC Annual Report and Recommendations at the Snohomish County Council's Public Works Subcommittee meeting on June 15, 2010.
 - Councilman Cooper praised Kayak Point Regional Park Restoration Design Option Three and the engagement of citizens in the visioning process as innovative.

- Councilman Somers expressed interest in the Derelict Gear Removal Program and asked if the MRC could investigate Snohomish County's oil spill preparedness and make recommendations to council.
- The MRC committed to making quarterly updates to the Council on projects and items in which the Council took interest.
 - Items on which they should be updated at the next meeting should include the June 16, 2010 net removal at Kayak Point and the paper "Mortality of Dungeness crabs (*Cancer magister*) due to lost traps and the cost benefit of removal in Washington State waters of the Salish Sea" by Kyle Antonelis, et al.
- Kathleen Herrmann presented the Kayak Point Regional Park restoration project at a Surface Water Management Staff meeting on June 16, 2010. Reactions from the presentation were positive and the project elicited interest from SWM staff.
- A meeting was held between Public Works Director Steve Thomsen, Kathleen Herrmann, Jerry Masters, Ginny Broadhurst, Sasha Horst, and Debbie Terwilleger regarding the direction of the Northwest Straits Initiative in 2011. Mr. Thomsen committed to personally assisting to route the Port Susan MSA Grant Proposal through the ECAF process.
- The 2011 MRC Budget should be discussed in October 2010. Funding from WMA fees should be dedicated within each project to maintain County support throughout the MRC work plan. This will also benefit administration and billing should Surface Water Management staff assist with project work.

MRC Survey Results- Tom Carter

- 8 out of the 10 current MRC members participated in the survey. It was intended to gage MRC member time commitments and project workloads. While the majority of MRC members feel they are contributing the appropriate amount of volunteer time, the survey indicated members feel the MRC could be doing more projects overall.
- Comments made by MRC members regarding the survey and strategic plan included:
 - Some questions were difficult to answer due compensated project time.
 - Survey shows MRC members are committing about 15 hours a month to projects and administration, so asking for 15 hours per month for new recruits is reasonable.
 - Falling short of strategic plan goals isn't a reason to distill its content.
 - No additional full time employees could be contracted to work for the MRC, as all funds are routed through the County.

MRC Project Updates- Kathleen Herrmann and Andrea Hennings

1. Port Susan MSA (PSMSA) Grant Proposal

- The Port Susan MSA NWSC Benchmark Fund Proposal was submitted for \$153,366. Main points of the proposal include:
 - Port Susan has been identified as a priority conservation area of high biodiversity importance within the greater Pacific Northwest by The Nature Conservancy (Floberg et al. 2004). A

variety of authoritative bodies in the Port Susan area results in a mix of regulations and management strategies which are not comprehensive or cohesive. The establishment of an ecosystem-based management regime will create consistency of management; provide a framework to measure progress; and institute adjustable management strategies.

- Designating a Port Susan Marine Stewardship Area (PSMSA) and adopting a community based marine stewardship plan will define a community vision for enhanced stewardship of Port Susan and lead to a greater understanding of the marine environment and ensuring Port Susan continues to provide diverse benefits for all people.
- The Conservation Action Plan used in the planning process will provide the framework to develop the PSMSA strategies for whole ecosystem recovery and allow all authorities and planning groups in the project area to adopt elements into their workplans for a more coordinated recovery effort.
- Beach Watchers and citizen scientists would collect data to identify critical threats.
- County staff is looking at how to distribute funds to the grant partners should this proposal be approved.
- The PSMSA resolution needs approval from the County Council. MRC Staff have been working to build internal support for this resolution prior to bringing it formally forward.
- ACTION: Kathleen will email the proposal to the MRC.

2. Recreational Dungeness Crabber Education

- The crabber subcommittee is close to finishing the outreach materials, including the nautical map and poster. Taylor Brown, a high school senior working with the subcommittee for a class project, developed a You-Tube video which is currently available online (www.youtube.com/watch?v=DutjF2TMBC0).
- A group of volunteers including Beach Watchers and others attended a training workshop on June 3, 2010 to coordinate an education and outreach strategy to coincide the opening day of the Dungeness Crabbing Season. Don Velasquez presented Dungeness crab biology and Washington State management, Brent Hackney demonstrated proper crab pot assembly, Chrys Bertolotto talked about outreach messages and strategies, and Andrea Hennings talked about the crab pot removal project, crabber survey, and reasons crab pots are lost.
- Outreach will take place on July 1-3, 2010. Anyone who would like to participate should contact Chrys directly. Materials will be handed out on those dates and given to sporting good stores and marinas for distribution to interested individuals.

3. Kayak Point Regional Park Restoration

- The MRC voted to use \$12,000 of Marjorie Mosher Schmidt funds to match a \$12,000 grant from People For Puget Sound to conduct a feasibility study for a pocket estuary in Kayak Point.
- Keeley O'Connell is drafting a Request For Proposals (RFP) for the feasibility study with the following draft timeline:
 - August 9, 2010: RFQ submissions due
 - Mid-September 2010: Snohomish County Engineers to conduct review of RFP's
 - October 2010: Award bid
 - October 2010- January 2011: Project work
 - February 2011: Project report due to Snohomish County MRC and SWM
- The feasibility study will answer the following questions:
 - How large would the estuary need to be for functionality?
 - What size side slopes and cross sections would maximize habitat value?
 - What would the size and orientation of the inlet need to be for the estuary to stay open?
 - What is the freshwater input available from the site?

- What is the habitat value to salmonids?
- What species could be expected to inhabit the estuary with restoration?
- Ideas for education and outreach regarding the pocket estuary included:
 - Use Beach Watchers to perform outreach regarding conceptual designs and value of pocket estuary during the summer
 - Stake out pocket estuary for public viewing during the summer
 - Survey for comments using Survey Monkey
- Two conceptual designs will be submitted to the NWSC with the second quarter Progress Report rather than a single alternative design. The main difference between the designs would be the inclusion of the pocket estuary in one of the concepts.
- The MRC letter to Parks regarding the three concepts supported elements rather than a single design. This should potentially leave the door open for MRC support of any alternatives created in the future.
- The final project should be presented to the Snohomish County Council Public Works subcommittee.

4. Nearshore Sediment Study

- Total project funding is \$167,000.
- Project goals:
 - Identify sites that have the high potential for beach rehabilitation.
 - Identify appropriate sediment sources and delivery modes for nourishment for beach rehabilitation.
 - Secure DOE, BNSF, & Parks support needed to advance sediment strategy to promote beach rehabilitation.
 - Evaluate approaches to restoration of shoreline functions along railroad-impacted shorelines.
 - While Dave Lucas, SWM Engineer, is currently the project manager and SRFB grant administrator, it does not have an MRC member lead.
 - ACTION: Lincoln Loehr volunteered to work on the project.

5. Mussel Watch

- MRC Staff is working with the Snohomish County Purchasing Department to extend and amend the current contract with TDI Brooks for analysis of mussel samples. The contract did not previously account for histopathology and gonadal indexing. This update will include this analysis to be consistent with NOAA protocols and reflect new sites added last sampling season.
- Regional project partners from the MRC, WDFW, and WA Sea Grant are writing a report about the Washington State expansion of the Mussel Watch project. This report will likely be completed at the end of July.
- The MRC has not received data from the previous two season's samplings (August 2009 and January-March 2010). The national program has been sending samples from before and after oil reached beaches in the Gulf of Mexico from the Deepwater Horizon Oil Spill. How this will affect the timeline for MRC samples is unclear.
- The next Mussel Watch sampling will take place in January or February 2011. While an extra sampling during summer 2010 was discussed previously, this is no longer possible due to the NWSC grant funding only the winter 2011 sampling and TDI Brooks increasing their costs.
- US Navy was conducting their MW sampling concurrently with WDFW and used the same site for one area in south Puget Sound. Samples from the Navy are analyzed at Pacific Northwest National Laboratories and data is received within a few months. These samples should be compared to the TDI Brooks samples from the same area to see if there is a significant difference in the data.

- ACTION: Lincoln Loehr will look into rates for analysis at PNNL.
- Using PNNL may cause problems with official NOAA sites, as data needs to be integrated into the national report.
- Lincoln Loehr and Mary Cunningham held a conference call with people in Skagit County who would like to begin MW sampling in their area to assess seafood safety and water quality.

6. Shore Stewards & Beach Watchers

• The Hat Island Beach Expo was held on June 12, 2010. Chrys Bertolotto gave a talk about crab pots, Katrina Hoffman from WA Sea Grant gave a talk about Puget Sound beach and bluff processes, and Ray Brown gave a talk about septic systems. 10 Shore Steward packets were handed out to interested residents.

7. Dungeness Crab Habitat Study

- \$5,000 WMA fees have been dedicated to this project.
- Currently a set of draft GIS maps have been developed by the initial data Snohomish County received from Washington DFW. The maps are now out of date due to acquisition of new data. This information needs to be compiled and new maps should be created.
- The MRC agreed to use some MRC staff time to organize data, finalize GIS Maps, and ensure project is neatly tied up for a report to be written in the future.

Rockfish ESA Listing Presentation- Dan Tonnes

Three of the 28 rockfish species within the Georgia Basin were listed under the Endangered Species Act in April 2010. Canary and yelloweye were designated as "Threatened" and boccacio were designated as "Endangered."

Most rockfish become reproductively mature after 15-20 years and some species can live over 150 years. Canary and boccacio have similar life histories, using the nearshore as juveniles, moving long distances throughout their lives, and spending most of their time suspended in the water column. Yelloweye don't use nearshore as juveniles and adults often have small home ranges, sticking close to bottom.

Preferred habitat types vary. Rockfish can be found steep but non-rocky habitat and are subsequently found in various habitat across Snohomish County waters, including Mukilteo, Everett Harbor, Port Susan, Edmonds, and Hat Island.

Common risk factors for their decline include length of time until reproductive maturity and naturally low reproductive rates, bycatch by other fisheries, and nearshore degradation. Other factors include contaminant build up in long lived species, a lack of natural connectivity between reproducing populations, climate change, and ocean chemistry.

New WDFW regulations have subsequently gone into place to protect all rockfish species. These include no retention of any rockfish species within Puget Sound and no fishing deeper than 120 feet when targeting bottomfish and other marine species (not including halibut or salmon).

NMFS has also partnered with the University of Washington to obtain a graduate student to develop a recreational angler survey project in 2011. This survey will cover their ability to identify rockfish species, how fishermen view recovery options, and their perceptions of Marine Protected Areas.

Local recovery efforts have had variable success at protecting rockfish. No hook areas in Canada have been able to reduce fishing pressure on rockfish in sensitive habitats. San Juan volunteer no take areas

have had less success, and have effectively turned into advertised fishing areas. This result was detailed in a paper by Eric Eisenhardt, et al, which Dan will forward to the MRC.

NOAA will begin working on Critical Habitat Designation and creating a recovery plan. In the meantime, MRC's can help the process through:

- Nearshore restoration and preservation, especially of eelgrass beds.
- Angler and public education about species identification, especially red rockfishes.
- Citizen scientist research and supporting local recovery efforts.

ACTION: Jerry Masters will set up a field trip to the NMFSC at Mukilteo.

MRC Administration Updates- Kathleen Herrmann

- MRC Member Recruitment

 - MRC members should begin recruiting people for applications. Jerry suggested the MRC develop a list of potential members.
 - MRC members must either be a resident or have a business in Snohomish County.

New Business

Jared Bond discussed the need for a clear and detailed Scope of Work (SOW) for each MRC project to ensure deliverables are met. This is particularly important for contracts, including those with the NWSC, WSU Extension, and Puget Sound Partnership, and should specifically outline deliverables to the MRC.

Existing projects may require an updated SOW for clarity of responsibilities and deliverables. Projects for the next round of NWSC funding will require updated or new detailed SOW's.

Jared Bond and Keeley O'Connell volunteered to work on establishing the SOW's. Responsibility for deliverables and timelines would then be transferred to project champions as appropriate.

No Sand Lance Left Behind: A Historical Review of Puget Sound Data- Jamey Selleck

The NWSC held a Pacific sand lance workshop in September 2009 to assess life history characteristics of this forage fish species. The workshop highlighted the lack of information regarding sand lance abundance and life history and outlined steps for future research. The new NWSC Forage Fish program is now working to:

- 1. Analyze historical datasets and determine sand lance distributions from previous sampling efforts, and assess the limitations and benefits of a regional beach seining project;
- 2. Produce GIS maps which detail presence/absence of sand lance as seen from the previous sampling efforts in nine counties;
- 3. Conduct sub-tidal research to gather new biological information on sand lance; and
- 4. Use results of the above studies to inform further research in 2010-2011.

Jamey Selleck was hired by the NWSC to compile historical data on sand lance and develop a report of his findings. The final report covers a period from March 1970 through October 2009 and includes 15,166 records from at least 1,432 sites. Two maps for each of the 12 counties in the Puget Sound region were developed with staff from Padilla Bay National Estuary Research Reserve: one shows sand lance presence/absence and the other map shows abundance.

Jamey Selleck and Caroline Gibson have a paper on this subject under peer review for publication.

Crabber Education Subcommittee Update- Brent Hackney and Andrea Hennings

The Recreational Dungeness Crabber Education nautical chart was not approved by the MRC prior to the first printing and distribution. All comments to the final draft were subsequently submitted by email and compiled for voting by the MRC. Changes as agreed upon by the MRC are listed below:

- MRC Logo- No metallic background
- Log boom route- All pink
- Change wording- "12,000 crab pots are lost each year in Puget Sound. Lost pots trap and kill 129,000 of your harvestable crabs."
- Action statements- recreate transparent bubbles around action statements as seen in previous drafts
- Chart title- Keep black, no transparency or metallic background
- Fonts- Use different font type for map elements and action statements
- Design- Clean up alignment of action statements, other text, logos, and map components
- Add more beaches and landmarks (i.e. McKees Beach, Warm Beach etc.)
- Laminate next printing with a heavier plastic

Ideas discussed for future drafts included adding the Marine Area 8-1 shoreline from Mukilteo to Edmonds and organizing a focus group of recreational crabbers to refine action statement language.

A final draft reflecting the changes listed above will be developed by the Crabber Subcommittee. MRC staff offered the assistance of the Snohomish County Graphics department if needed. The revised chart will be emailed to the MRC for review prior to the August meeting.

Snohomish County Oil Spill Preparedness Response- Kathleen Herrmann

County Council Chairman Cooper asked the MRC to investigate the risk of oil spills in Snohomish County and Puget Sound. He offered to support this effort and asked for any policy recommendations to be proactive in planning for this type of event. He also noted a previously established task force which was working on recommendations approximately five years ago.

MRC staff is assessing an opportunity to partner with the UW Environmental Management Certificate Program develop a report and list of recommendations regarding oil spill preparedness in Snohomish County. This 20-week program pairs an interdisciplinary team of students with an academic advisor to solve real-world environmental questions for community organizations seeking specialized technical or managerial assistance. Acting as consultants, the teams experience the practical demands of the professional world while allowing students to apply their coursework in a controlled setting. The program normally costs community organizations \$7,000, but the UW is willing to work with the MRC to consider a discounted application fee. Mike McGuiness from Snohomish County SWM is currently looking for funding on behalf of the MRC.

• Action: The MRC will sponsor students from the UW Environmental Management Certificate Program to develop a list of recommendations to the County Council for oil spill preparedness if the application fee (\$4000-\$7000) can be obtained to fund the project.

Plastics at SEA Presentation- John Miller

John Miller of Naval Station Everett spent June 10-July 14, 2010 in the North Atlantic on the SSV Corwith Cramer as part of the Woods Hole Oceanographic Institute's Sea Education Association (SEA) program. The goal of the expedition was to document the abundance and distribution of plastic in areas which had previously been unexplored by the program. SEA conducts most plastic tracking in the Atlantic's Gulf Stream gyre as part of the first federally-funded research expedition dedicated to examining the accumulation of plastic debris.

The 2010 North Atlantic research collected samples in an area which had not previously been studied. Calculations based upon the resulting data suggest approximately 13 pounds of plastic per square mile of open ocean. Only two fish were caught during the expedition, one of which contained plastic debris.

Possible solutions for the reduction of plastics in the environment include additional recycling, use of other packaging materials, establishment of manufacturing and distribution best

management practices, and anti-litter campaigns. Similar projects could be conducted in Puget Sound. Locally available nets are the current limiting factor.

MRC Strategic Plan Update- Tom Carter and Kathleen Herrmann

Tom Carter worked with MRC staff and Executive Subcommittee members to revise the MRC Strategic Plan Goals, Objectives, and Strategies. Revisions were drawn from material contained in background drafts, Snohomish County code, and the NWSC strategic plan. MRC staff edited further for clarity and continuity with other MRC documents.

These sections were defined as:

- Goals- Broad courses of action that include one or more objectives
- Objectives- Specific statements detailing the desired accomplishments or outcomes of a particular set of activities within a project
- Strategies- Steps taken by project staff and/or partners designed to reach the project's objectives

Goals and Objectives pertaining to climate change, ocean acidification, and specific actions regarding reopening of shellfish beds were not included in the original draft Strategic Plan due to the complexity of these issues and the 5 year time frame. Shellfish bed reopening could currently fit under "Goal 2: Protect and restore marine water quality in Snohomish County" as a strategy.

Action: MRC members will submit comments on overall Goals and Objectives by September 6, 2010. Final draft Strategies will be submitted before the next MRC meeting. Voting on Goals, Objectives, and Strategies will take place at that meeting. The last draft of the Strategic Plan from 2008 will be sent to the MRC for reference.

MRC Project Updates- Kathleen Herrmann

Kayak Point Restoration

Project partners have drafted a Scope of Work (SOW) for a pocket estuary feasibility study which will be sent to the MRC Executive Subcommittee for comment through email.

This project was previously under consideration for Puget Sound Nearshore Ecosystem Restoration Project (PSNERP) 10% design funding through the Army Corps of Engineers. This may no longer be a possibility.

The Everett Herald ran an article on August 18, 2010 about progress on design plans for the park.

The third year of pre-restoration monitoring was finished by WSU Beach Watchers. Hugh Shipman from Washington Department of Ecology will examine the collected data and provide additional comments and suggestions for future monitoring plans. Some statistical analysis of the data may be completed, possibly by a University of Washington School of Marine Affairs (SMA) student.

Nearshore Project

The Snohomish County Habitat Specialist position vacated by Arden Thomas will not be rehired. Kathleen Herrmann and Dave Lucas, Snohomish County Engineer, will work with Anchor QEA through an on call contract to conduct modeling and technical work for this project. The Snohomish County Communications Department has a facilitator who will work with Kathleen to conduct stakeholder outreach.

This project will assess the railroad as a barrier to sediment transport, feasibility of artificial sediment transport mechanisms in the study area, and conduct a series of stakeholder workshop to identify possible solutions. Burlington-Northern Santa Fe (BNSF) railroad, Hugh Shipman (Washington Department of Ecology), Katrina Hoffmann (Washington Sea Grant), and Jon Houghton (Pentec Environmental) have been named as possible stakeholders to participate in the workshop.

Action: Lincoln Loehr will review the draft project SOW with Peter Hummel from Anchor QEA. Mary Cunningham may also review the SOW.

Port Susan MSA

Sarah Haynes of the Island County MRC and Kathleen Herrmann presented the Port Susan Marine Stewardship Area (MSA) project at the July 30, 2010 NWSC meeting. The project was well received by meeting attendees.

Regular Core and Advisory Team meeting dates were established and the Citizen Science Team will conduct additional meetings. The Nature Conservancy's Conservation Action Planning (CAP) next step will produce a list of stakeholders for the October Critical Threats workshop.

NWSC will establish three separate contracts with Snohomish County, Tulalip Tribes, and Washington Sea Grant and distribute benchmark funds directly to those groups. Staff time from Sea Grant will have no associated overhead.

Washington Sea Grant is accepting applications for a University of Washington student to serve as project coordinator. Kathleen Herrmann, Abby Hook (Tulalip Tribes), and Kate Litle and Michelle Wainstein (WA Sea Grant) will select a student by September 1, 2010.

Recreational Crabber Education

Jared Bond noted the absence of black dots on the base of the nautical chart's Port Susan side buoy icons. He proposed to amend the icons for consistency.

- Mary Cunningham motioned to approve the amendment. Brent Hackney seconded the motion, which was unanimously approved.
- Mary Cunningham motioned to approve the nautical chart as amended. Lincoln Loehr seconded the motion, which was unanimously approved.

Over 900 crabbers received nautical charts from July 1-3, 2010 through face-to-face outreach at boat launches and marinas across Snohomish County. Approximately 1,400 charts have been

handed out to date. This includes distribution by the MRC and WSU Beach Watchers at events like Beach Expos, Warm Beach Summerfest, Stillaguamish Festival of the River, and the Evergreen State Fair. An opportunity for further targeted distribution includes dock walking at marinas. Approximately 500 charts are left, as the printer created more than the anticipated 1,500 copies.

Gravid Female Dungeness Crab Habitat Study

The MRC requires any additional sampling data for this project from Tulalip Tribes and WDFW by Wednesday, August 25, 2010. The project summary paper by Andrea Hennings and GIS habitat maps by Snohomish County staff will be finished after any additional data is received.

Action: Jerry Masters will contact project partners at the Tulalip Tribes to ensure any remaining data is received by August 25, 2010.

Shore Stewards

An additional Shore Steward Shoreline Landowner Workshop will be held in the Picnic Point Regional Park area of Snohomish County in January 2011.

Warm Beach Summerfest on August 14-15, 2010 resulted in the Snohomish County Shore Steward program's 400th enrollee.

WSU Beach Watchers

A Beach Watcher has begun working on development of a bulkhead alternative brochure for local permit centers. The document will include review and input from multiple partners.

Snohomish County Shoreline Master Plan Update- Mary Cunningham and Kathleen Herrmann

The MRC's comments to the Snohomish County Shoreline Master Plan (SMP) update were not considered due to submittal after the deadline. Washington Department of Ecology (DOE) has subsequently submitted comments to the plan, of which one is in conflict with MRC recommendations.

The existing MRC letter to County Council and the Executive was modified to reflect this comment. It states the MRC supports DOE's recommended action in Amendment Tracking Sheet item 10 and include the addition of no new flood control structures "in critical saltwater habitats." References to sea level rise should be omitted, as DOE has not approved any plans in which such provisions were included.

The letter was also amended to highlight currently limited public access to the shoreline and the further restrictions the SMP update may have upon future access.

Action: An email with MRC's original SMP Update comment letter and a version reflecting new changes will be sent to MRC members. Voting will take place through email, after which the letter will be sent to the County Council.

The MRC thanked Mary Cunningham for her work on compiling comments on the SMP Update.

Action: Mary Cunningham and Jared Bond have read Mukilteo's SMP update can develop draft comments for the MRC before the September 23, 2010 deadline.

UW Oil Spill Response Project

Tom Carter and Sara Booth, graduate students from the University of Washington's Environmental Management Certificate Program presented their vision of the Snohomish MRC Oil Spill Prevention/Preparedness Project. Six project objectives were identified and separated into two phases along with project constraints.

Project Objectives:

- 1. Investigate single-source oil spill prevention and preparedness laws, regulations, and programs at federal, state, and county levels (*Phase 1*)
- 2. Examine environmental impacts of single-source marine oil spills and related treatment methods (*Phase 1*)
- 3. Assess spill threats to Snohomish County interests and resources (*Phase 1*)
- 4. Identify threats to social, environmental, and economic interests (*Phase 2*)
- 5. Develop and compare a suite of options that the County can implement (*Phase 2*)
- 6. Deliver findings and options (*Phase 2*)

MRC Members provided feedback to the UW team. Highlights of this discussion include the need to see the spill scenario graphics in the final report along with an executive summary that is appropriate for general public outreach. The Beach Watchers have training and interest in assisting with spill response. The team was reminded that that oil spill response is a front-burner issue for NWSC. People For Puget Sound's toxic outreach program may be interested in coordinating as well.

A general discussion around oil spill threats that were not included in the project plan included:

- Single hull barges
- Derelict vessels as a source of oil
- Impact of spills outside of county boundaries
- Hat Island Marina

Action: Dawn Lawrence and Chrys Bertolotto volunteered to help as they are able and would like to be included on project emails. Jerry Masters will meet periodically with UW team on Tuesdays as he is available.

MRC Strategic Plan Update- Tom Carter and Kathleen Herrmann

Tom Carter presented the revised goals, objectives, and strategies as edited to incorporate both the prior 2008 Draft Strategic Plan and the need for a streamlined plan. SMART is an acronym that refers to objectives that are Specific, Measurable, Achievable, Realistic, and Time were discussed as a potentially desirable addition to the strategic plan. The MRC decided that this would require a level of work that would be difficult to achieve at this time. Kayak Point Restoration

The Request for Proposals (RFP) for a feasibility study of a barrier lagoon at Kayak Point County Park has been posted. Two park design options were previously established and will be used in this study. These two options (option A and option B) differ in the placement and configuration of the lagoon. Proposals are due by October 25, 2010 at 5 pm. MRC staff will partner with the Parks Department and PFPS for review of proposals and interviewing selected firms. The project will be awarded by November 15, 2010. The final draft of the feasibility plan will be presented on March 15, 2011.

Nearshore Sediment Study

MRC staff are working with Anchor QEA and Snohomish County Communications Department. Anchor QEA is on retainer for Snohomish County and a scope of work has been developed. MRC support is needed to continue moving this project forward.

Ocean Renewable Energy Overview: Implications for Local Marine Management- Simon Geerlofs

Simon Geerlofs, from Pacific Northwest National Lab (PNNL), presented on ocean renewable energy and the work being done in Snohomish County. PNNL is a U.S. Department of Energy national lab and is operated by Battelle. There is a PNNL marine research laboratory in Sequim and a satellite office in Seattle. Simon works in the Seattle office to understand and mitigate the impacts of tidal and ocean energy systems on coastal ecosystems.

Ocean renewable energy is a growing area of research and has seen a recent increase in funding. Ocean energy is more predictable than wind or solar energy and is a potentially large resource in coastal states like Washington. Snohomish PUD is exploring tidal current potential in Admiralty Inlet using OpenHydro technology. Tidal current technology generates energy from the movement of water in and out of Puget Sound. One consideration of this work is how to prevent animal interactions with the OpenHydro. Work is underway to develop a system that uses active sonar to detect whales approaching the turbine so that the turbine can be stopped if necessary. Additional consideration must to given to how much energy could be removed without disrupting the system.

Other ocean energy technologies include wave energy and offshore wind. Wave energy harnesses the movement of water. The Makah tribe is exploring this technology with limited success thus far. Offshore wind energy is not a current focus for Washington because current generating stations must be anchored in shallow water. The Washington coast does not have areas of shallow water that are not visible from land. For all ocean energy technologies there are potential environmental impacts that must be considered.

The Marine Research Laboratory is also involved in modeling work. Modeling is used as a tool for characterizing the impacts of development and restoration work to understand how the system in question functions. For example, for the Snohomish River restoration modeling is being used to examine how multiple projects will come together and impact the system as a whole. Several additional projects are also taking place in Puget Sound.

MRC Project Updates – Kathleen Herrmann

Kayak Point Restoration

The Request for Proposals (RFP) for a feasibility study of a barrier lagoon at Kayak Point County Park was posted and three firms applied. Staff from Snohomish County, Snohomish County Parks, and People for Puget Sound reviewed applications and conducted interviews. The consulting firm, Coastal Geologic Services (CGS) was selected. The final draft of the feasibility plan will be presented March 15, 2011.

Action: Kathleen Herrmann will provide a project schedule to the MRC.

Nearshore Sediment Study

The County finalized the contract with Anchor QEA for services to assist with the Nearshore Sediment Study. The first stakeholder workshop is tentatively scheduled for January 13, 2011 from 9:00 AM to 12:00 PM at Willis Tucker Park. This 3-hour workshop will provide participants the opportunity to review the criteria for which to identify the highest priority sites for habitat restoration for the section of nearshore along the railroad-impounded shoreline from Mukilteo to the Port of Everett.

A total of three workshops will be held to bring technical, policy, and regulatory perspectives to the table. They will take place in January, March and May, 2011. In addition to identifying critical knowledge-gaps and project-related barriers, other policy and permitting issues that influence project selection and restoration maintenance will be raised early in the assessment.

Action: Kathleen Herrmann will provide MRC members with a copy of the Anchor QEA scope of work.

Port Susan Marine Stewardship Area

The Strategies Workshop will be held Wednesday February 9th and Thursday February 10th. Responses from the Plus/Delta assessment at the Threats Workshop were reviewed. Some workshop participants expressed discomfort over the CAP process. In response, all participants will be sent a successful CAP example, a conservation audit example, and a workshop summary. The Warm Beach Camp facilities were very cost effective and should be considered for future use. In regard to workshop structure, participants should be encouraged to attend both days and effort made to avoid having people come only for one day.

A joint effort by Chrys Bertolotto, Scott Chase, Kate Litle, and Michelle Wainstein is underway to conduct a Citizen Science Inventory of all the projects in Port Susan. An inventory list should be available for review shortly. A Citizen Science Project Selection meeting held November 17, 2010, to evaluate potential projects. The next meeting will be on Thursday, December 16th in Tulalip.

Mussel Watch

The MRC worked in partnership with the Washington Department of Wildlife last year using State funding to collect all the Mussel Watch samples for the State of Washington using citizen scientists to save NOAA money that was previously needed for a consultant. A project report can be found at: <u>http://wdfw.wa.gov/publications/pub.php?id=01127</u>.

Currently, there are several challenges to this project. Snohomish County has not received data since 2008 and the data received is incomplete. The MRC recognizes the importance of providing data back to citizen scientist volunteers. Samples submitted in January 2010 have not yet been processed despite the high priority of Washington State Mussel Watch in part due to effects of the Deepwater Horizon Oil Spill on TDI-Brooks Laboratory. The current Snohomish County contract with TDI-Brooks laboratory has expired and at this time, the County is working to move forward with a Sole-Source Contract with TDI. Issues relating to past samples and payments still need to be resolved. NOAA staff and several MRC members and staff discussed these issues on a conference call on November 15, 2010. The sampling plan for this winter is currently under development and is dependent on the outcome of contract negotiations.

Action: Inform Chrys Bertolotto when sampling dates are established.
